Michael's interest in art began as a child watching
his father draw & paint. He moved from Kansas to
N.Y. City in 1978 where he studied at The Art
Students League, Salmagundi Club, & took private
classes with Bill Weltman. Pat Carlson became his
agent and his work was then represented by
national publisher & gallery chain Dyansen. In a
national competition he was chosen to paint the
22 foot historical mural, "Brown vs. the Board of
Education," which was completed in 2018 & hangs
in the State Capitol in Topeka, KS. Michael's art,
prints, & posters have a subtle humor & crispness
of detail perfectly suited for Art Deco styling. He
has exhibited widely throughout the U.S., Europe,
& Japan. He resides in the Kansas City area.
